

Catch Mid-Winter Meltdown Mini Super Nintendo Entertainment System Giveaway

Terms and Conditions

1. Eligibility

Australian residents aged 18 years or over are eligible to enter this Promotion. Employees of the Promoter (or any related entity of the Promoter) and their Immediate Families are not eligible to enter this Promotion.

2. Entry

By entering this Promotion, the entrant accepts these terms and conditions. A person may only enter this Promotion during the Promotion Period. Entrants agree to the Promoter's Privacy Policy (<http://www.catch.com.au/privacy>) and to receive promotional email alerts (that they can opt-out of at anytime). In order for the Promoter to deliver the prize, the entrant must provide his or her full name, delivery address and contact if requested, via email. The Promoter may deem an incomplete entry invalid. To enter, entrants must complete the online entry form when prompted during the Promotion Period, providing their email address.

3. Prize

There will be a total of 10 prizes (10 winners). Each winner will receive 1 x Mini Super Nintendo Entertainment System valued at \$119.00 each. These prizes are on pre-order, and will be delivered in October. The total prize pool is valued at \$1190.00. Prizes are not transferable or exchangeable and cannot be substituted for cash. If a prize is unavailable, the Promoter may substitute that prize with a prize that is equal in value or type, subject to any written directions from a regulatory authority.

4. Draw

This is a game of chance. The winners will be randomly drawn at 2pm AEST 31st of July 2017. The prize draw will take place at the Promoter's office.

5. Winners

The winners of the prizes will be announced on the Promoter's website (www.catch.com.au) and Facebook account from 3pm AEST 31st of July 2017. The winners of the prizes must sign any release form that may be required by the Promoter or supplier of a prize. Catch may verify the winner's age before providing a prize. After announcement of the winners, the Promoter will notify the winners via email to collect delivery details.

6. Unclaimed prize

If a prize is unclaimed, the Promoter will draw a winner for the unclaimed prize 3 months after the initial draw, using the same method specified in section 4 and will notify the winner using the same method specified in section 5. The draw will take place at the Promoter's office.

7. Forfeited prize

The Promoter may forfeit a prize if a winner refuses to sign any release form specified in section 5 or if a winner refuses to accept a prize.

8. Entrant's personal information
